#### You're On Trial... for Health Officers and Registered Environmental Health Specialists (3CE's)

You will start with your initial meeting with your legal counsel. You will do the final preparation of your case. You will review the law that applies to your case. You will receive instruction in the Rules of Evidence and court procedure. The burden of proof will be outlined. You will review forums where testimony may be given, including the procedure and burden of proof of each forum. Each participant will then have their turn on the stand. A critique of each turn on the stand will be given.
